

GRIFFIN & HOWE FIREARMS STORAGE AGREEMENT

Griffin & Howe is pleased to provide storage for firearm(s) in an alarmed and climate controlled environment. The firearm(s) that we take in for storage must be legally owned and possessed by you, the customer. We have no limit as to the amount of time we will hold firearm(s) in storage, but do require that if you have a change of address or any other contact information during the time that your firearm(s) are in storage, that you inform us of these changes.

The fees for storage are \$300/firearm/year plus insurance which is \$7/\$1000 value of the firearm(s)/year. This includes inspection & remedial cleaning of the firearm(s) annually. You will be invoiced at one year intervals with the first years' payment due when you bring the firearm(s) in. Each subsequent year will be billed in advance on the anniversary of the date the firearm(s) were initially left with us for storage. If you do not keep your firearm(s) in storage for an entire year, you will be credited for unused time. Failure to pay the storage fees within a 30 day period will result in finance charges of 1.5% per month. Accrual of unpaid storage fees can result in involuntary confiscation of the firearm(s) by Griffin & Howe as compensation for services rendered. Our insurance policy carries a \$1,000.00 deductible which, in the event of loss or damage, the client is responsible for.

According to State & Federal law, in order to return firearm(s) that are left with Griffin & Howe for storage, the owner must undergo a NICS (National Instant Criminal Background Check). This means that if you leave your firearm(s) with us as storage for more than 24 hours, the firearm(s) cannot be returned to you without meeting the requirements for the transfer of a firearm in the state where you live. In New Jersey in addition to a NICS, you would need to have a NJ Firearms ID Card (FID) and a valid driver's license with matching addresses to take possession of your firearm(s). If you live outside of NJ the firearm(s) would be shipped to a firearms dealer of your choice. In the event that the firearm(s) are part of an estate and you are to receive the firearm(s) as the result of an estate settlement you will be required to provide us with documentation from the lawyer of the estate showing that the firearm(s) are to be released to you. If handguns are a part of the collection that you wish to store with us and you are a resident of NJ, in addition to a NICS, NJ Firearms ID Card and valid driver's license, you will need to provide us with a Handgun Purchase Permit. Only one handgun per Handgun Purchase Permit can be returned within a thirty day period. Note that any unpaid fees for storage must be paid before firearm(s) can be returned.
